Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered in their current residential precinct, i.e., voters registering to vote on Election Day and voters changing precincts, must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence, if required) has the following options: 1) may have the voter's identity/residence attested to by another regis-
