As the winter season approaches, the County Engineer would like to remind the rural residents and travelers about the County's Snow Ordinance. Adopted in 1995, this ordinance was implemented due to economics and liability.

After a snowfall, the initial effort

is to open paved roads at least to one lane traffic as soon as possible. Further opening of hard surfaced roads and the clearing of gravel roads then follows. Normal snow removal hours are 7:30a.m. to 4:00p.m. When conditions deem necessary, crews will be on the job from 5:00 a.m. until dark. Paved roads will be sanded during normal working hours. Boone County will not provide a "dry" pavement con-

The ordinance advises motorists

to drive according to the conditions. Motorists should reduce their speed at least 25 m.p.h. below normal driviag conditions Drivers should use extra caution at intersections, railroad crossings, curves, hills and
